The first to call was Bill Simons who knew that it was a hoax, but wanted to make certain that it wasn't. That was the first of many phone calls to alert us of what was happening. To all of you Patty and I thank you for your kindness.

We turned on to our yahoo account and it was completely gone. What we lost was the address book and everything else that was provided by yahoo.com.

All the while we were working to get the word out that our yahoo account had been invaded and that our main internet provider was now our email address: asagreenhornet@comcast.net

My response: I, too, am getting burned out and will continue only as long as other vet's assist me in finding other ASA Turkey vets.








