The article goes on to say: "The Association enjoyed a large turnout at the meeting, which afforded many E-5's the opportunity to hear, for the first time, the constitution of the association and its three-fold purpose". Ken informs that he QB'd the Hq Co team that beat Jim Hatmaker and Operations Co., 7-6. Ken said that he had taken many photo's and slides during his TOUR of DUTY at Manzarali as a 20 year old. He promised to write his BIO but never got around to completing it. Ken said he was a charter member of the SCOTCHMAN Club that was forced to cease operations.

On 14 March 2009 I dialed up Ken's number and his wife, Suzette, politely told me that Ken had passed away on 9 September 2008, age 62, at the Community Hospice House, Merrimack, NH. His death was from the silent Pancreatic Cancer and that he was sick for 3 weeks before the end came. She further told me that Ken had graduated from high school outside of Fort Worth, TX and had lived in that area for more than 15 years before joining the ASA.

Suzette informs that she was from Nashua, NH and met Ken at a Sunday nite dance at Fort Devens. He had just signed in at Devens from his Turkey assignment and two weeks later they were engaged. For many years they kept in contact with Andronaco and at Ken's death she could not contact him.

After 11 years of marriage Ken established and operated Fiber Care Systems, a residential/commercial carpet cleaning business in Milford for 38 years. The Better Business Bureau of New Hampshire had declared that Ken's business was the best carpet cleaner in the area. They had 3 son's and two of them now operate the business.

Ken enjoyed camping, cooking and loved to travel. He especially enjoyed his vacations to the Islands. In addition, he loved watching the cooking channels, Westerns and was a

history buff.

Family members include his wife of 40 years, Suzette M. (Paradise) Brown of Milford, NH; three sons and daughters-in-law, Kevin C. The other date didn't show and they partied with Penny. It was soon that Chuck and Penny realized that they were meant for each other and this year they will celebrate 46 years together. They have 4 daughters and 2 sons. Chuck is retired from General Motors where he worked in the GM Technical Center as a chief in the Cadillac Division for 36 years that includes his 3 years in the ASA.

# In a message dated 3/1/2009 9:20:49 A.M. Eastern Standard Time, penelope@mwci.net writes:

Chuck may or may not have told you..knowing him he probably didn't, for the last 6 months he has had first sciatic nerve pain in his leg, which was taken care of with

therapy, then his back started hurting - he went to a chiropractor, had MRI's and was given pain pills and muscle relaxants. Last week he felt well enough for us to take a 4 day trip to S.C. to see Jenny and the children, we flew of course and he had some discomfort, but seemed OK. We walked a little in Charleston, but the rest of the time he spent resting. He cannot lay down in a bed so has slept upright in a chair that can be pushed into a reclining position. I don't know how he stood the pain which he finally acknowledged and I took him back to the Dr. who took another MRI and made an appointment with a neurosurgeon-next week.

On Friday he called me at work - he had lost feeling in his legs. I called an ambulance, amazingly our son came at the same time as the ambulance-apparently Jenny had called Mark and told him to convince Chuck - to get to a specialist - he still thought he had twisted a muscle in his back and the relaxants would take care of it. Basically I think he had heard so many negative stories about back surgery that he didn't want to face that possibility. Anyway the Drs at U of Michigan took one look at him and put him on morphine and did more MRi's .

He went into surgery that night. They found a mass in his spine that was pushing the bones over the nerves. They put in two rods and pins and sent the mass to be biopsied. The Dr was very abrupt and told me this with the aid of a drawing board. Needless to say I was in shock. We won't find out the results of the biopsy for 5 days which will be Wednesday, the 25<sup>th</sup> of February. The Dr said he is hoping it will be scar tissue from falls Chuck has taken in the past-darn that Michigan ice!

He came out of surgery on Saturday morning, he was heavily sedated but happy to finally be without pain.

Yesterday (Sunday, 22 Feb) they weened him off the morphine, he is talking, laughing at Mark and Laura's stories and finally got to eat something. He is still in the ICU and they did a CAT scan. We won't know the results of all the testing until later today or tomorrow. He hasn't been told about the mass yet, there is no point worrying him and he is talking already about going home. He can move his legs, which is great but says his back doesn't hurt but feels "weird". I am going back to the hospital now.please keep him in your thoughts and prayers.

#### Hi...this is P-en-e-l-o-p-e!!

When we spoke a few weeks ago you were going to show me how to find the Days on the internet, now would be a good time as Chuck is home until the 6th April when he will have a kidney removed. He can't use his computer but mine is still up and running. He is having radiation for 10 days and is feeling tired, but so far no other side effects.....best wishes, Chuck and Penny Teschker

On 30 March 2009 I called Chuck and Penny to follow up on his health. Talked for over and hour with Chuck and he was up-beat about his upcoming kidney operation. While talking I decided to ask questions about his time at Manzarali Station as I had no BIO from him. Chuck said that his draft notice was in the mail, so to speak, and he decided to visit the US Army Induction Center at Fort Wayne in Detroit for information on what was available if he enlisted. The ASA recruiter did an excellent job of selling ASA as the way to go. With that in mind he enlisted and was sent to Fort Leonard Wood for basic training. During the in-processing they called out names of those who would remain at Leonard Wood for basic and Chuck and the others were on the way to Fort Hood, TX for basic. It was there that he made friends for life with the late Nelson Murray. After basic Teschker and Murray were headed for Fort Devens for ditty-bop training. Both washed out of the dits and daws training and were sent to non-morse (059) training which neither objected to. Upon completion both were assigned to Det 27, an assign- ment that both thoroughly enjoyed. The equipment was brand new and they more or less were the guinea pigs. Chuck readily admits that he was hard of hearing, but for some unknown reason he was able to ID signals better than the others. For this reason he was promoted to a hard stripe buck sergeant and used as a floating instructor to train

all the 059's at Det 27. As such he got to know the young Watch Officers, Freddie Frye, Ralph Stevens, Jud Reynolds and Bobby Mize. When he arrived at Manzarali they were having try-outs for the baseball team that would be representing Ankara in a MSC tournament in Libya. 



The above is a Dehaviland Otter with the Army designation of U-1A. It held about 10 people. This was not the Otter we had when I was there. Ours was painted with black paint on the green. It also had a picture of a donkey on the couling in white with Esek Airlines painted in white there as well. I cannot recognize anyone in the picture. There is one Turkish fireman in the photo. The man on the extreme left. They always stood at a modified parade rest. When I was there we wore red baseball caps as a safety measure. This picture was taken in front of the hanger which is located at the rear of the fire truck parked there. The GI standing next to the fireman is holding a mailbag.



The above looks like a Dehaviland Beaver, a U-6A. It is a little smaller than an Otter. We did not have a Beaver assigned to us when I was there but one did occasionally land there. The

picture is taken before the summer of 1969 as that was when they changed the sign to a fancier version. That one read Welcome to Sinop, TUSLOG Det 4, elevation 4 feet. There is perforated steel planking (PCP) in the foreground.





Elder, I'm just reading the DOOL #197 part with the info on avoiding the draft by volunteering for ASA. I, also, avoided the draft by volunteering for ASA. It wasn'r meant to happen in that way, but it did. My 1A arrived the day I graduated from Stephen F. Austin State University with a BSF (Bachelor of Science in Forestry) on 23 August 1969. I knew I had 30 days hence to report. While between college and the draft I walked into the army recruiter station in Hartford, CT to see what was available. I chose land surveying because that's what I enjoyed very much in college but my eyesight was not good enough for the engineers - the signal corps would take my eyesight for their land survey course but the course was like the spring of 1970 -- after I would be drafted.....but these things actually occurred after the next part. The recruiter sent me to New Haven, CT to take the inductee medical & aptitude exams. After the medical and aptitude tests were taken, a bunch of us were herded into a room where a Sergeant told us about a 4 year enlistment of jobs he couldn't tell us about...he was from ASA. So I had this option when I went back to the recruiter and that's when he informed me about the eye problem with the engineers school, the time problem with the signal corps and the draft breathing down my neck, and so I told him I'd then go for the ASA enlistment. I volunteered in the US Army on 21 September 1969. I've never looked back. I've never worked in forestry either. I'll have 39 years US Govt service this July. 
