

I received word 17 June 2013 from Nels Johnson via Dan Taylor that our friend Tony Antonello recently had a medical emergency that required surgery at Walter Reed and that he is now home recuperating under the TLC of his wife Val. We called Tony and he informed that he became ill on 31 May and thought that his sinus was acting up, but it kept getting worse and he went to the Fort Belvoir hospital. Their tests found that he had a subdural hematoma of his head which occurs when blood veins ruptured between his brain and the outermost membrane layers that cover his brain. He was immediately rushed to Walter Reed for surgery. A hole was drilled into his skull to drain the leaking blood and it was successful. and required 26 stitches. Any honorably discharged veteran is entitled to a burial flag, which upon interment is folded and presented to the family as a keepsake. Usually the funeral director will acquire the flag for the funeral; however every veteran and the family of every veteran must be aware of the free flag provision and remind the funeral director.



Sinop was a good place to be stationed. After we became operational, our success came one night, when the group intercepted their first inter-continental ballistic missile fired from the Russian site in Kapustin Yar. The success of this intercept was sent directly to President Dwight Eisenhower.

My father, Ray Keane, was the secret courier who took this information directly to the Pentagon. He said it (a reel?) was padlocked to his body under a suit of civilian clothes and he flew on a commercial flight (with a pistol!) from Istanbul to DC. He delivered the reel directly to the Pentagon and went straight back to Turkey.

I feel that surely the records of my father's secret mission have been declassified by now but I have no idea of how to look for them.

I'm very sorry to learn that Jim Mulholland passed away in 2011. I treasure the photo you posted of Jim and my father in DOOL #195.

I wish my father could have attended a Turkey reunion. How he would have loved that!! I am grateful for all you have done to record the memories of everyone.



Richard Roy Swearingen was born right in French Camp, CA. and brought up in Lodi, CA. When he was about 4-5 the family moved to Oakland, CA during the WWII to work in the Shipyards.

After the war, the family moved to San Leandro where he attended his primary schooling, and after graduation from High School, he joined the US Army and did his basic training at Fort Lewis, WA.

All of our water was hauled up via truck. Each man had a personal water jar which our houseboy kept filled; except when the weather was bad and the water truck couldn't make the trip due to muddy unsafe roads - there were no paved roads anywhere except downtown Sinop.

The houseboy kept our water jugs clean by sloshing around a handful of dirt/gravel mixed with a little water to rid the vessel of calcium and other mineral deposits - no running water.

Water when available, for the shower building was gravity fed via a water tank on the roof.
